#### 1 Short title

This regulation may be cited as the *Queensland Reconstruction Authority Regulation 2011*.

### 2 Disaster event—Act, s 6(c)

For the Act, section 6(c), the following are prescribed as disaster events—

- (a) the floods caused by heavy rains in February 2011;
- (b) the floods and landslides caused by heavy rains in March 2011:
- (c) a flood, landslide or other disaster, within the meaning of the *Disaster Management Act 2003*, caused by heavy rains in April 2011.

### 3 Declaration of reconstruction area—Act, s 43(1)

(1) For the Act, section 43(1), the area marked as the reconstruction area on the map called 'Declaration of Reconstruction Area - Grantham' prepared and held by the authority is declared to be a reconstruction area.

# 4 Approval of development scheme for the Grantham reconstruction area—Act, s 74


For the Act, section 74, the development scheme for the Grantham reconstruction area is approved.
