1 Short title

This regulation may be cited as the *Education and Care Services National Law (Queensland) Regulation 2011*.

2 Commencement

This regulation commences on 1 January 2012.

For section 32 of the Act, definition *central governing body*, the following entities are prescribed—

- (a) the Association of Independent Schools of Queensland Inc;
- (b) the Corporation of the Roman Catholic Bishops of Queensland;
- (c) the Creche and Kindergarten Association of Queensland;
- (d) Queensland Lutheran Early Childhood Services;
- (e) the Gowrie (Qld) Inc.
