## **CORRECTIVE SERVICES (ESTABLISHMENT OF PRISONS) REGULATION 1992**

[as amended by all amendments that commenced on or before 3 September 1999]

### **Short title**

1. This regulation may be cited as the *Corrective Services (Establishment of Prisons) Regulation 1992*.

### **Places no longer prisons**

2. The Moreton Correctional Centre and the Wacol Correctional Centre as in existence on 31 December 1996 are places declared to no longer be prisons.

### **Places declared to be prisons and names assigned**

3. The places described in the schedule are declared to be prisons and the name assigned to each prison (if any) is the name set opposite the place in the schedule.

### **Reference to plans**

4. A plan mentioned in the schedule is a plan registered in the department in which the *Land Title Act 1994* is administered.

### **Repeal**

5. The order in council made under the Act and published in the gazette on 24 June 1989 at pages 1809 and 1810 is repealed.
