# Disability Services Regulation 2006

## Part 1 General

### 1 Short title

This regulation may be cited as the *Disability Services Regulation 2006*.

### 2 Commencement

This regulation commences on 1 July 2006.

### 3 Dictionary

The dictionary in schedule 4 defines particular words used in this regulation.

### 3A Prescribed disability services—Act, ss 12, 14 and 16A

For sections 12, 14 and 16A of the Act, the prescribed disability services are stated in schedule 1AA.

### 4 Fee for application for prescribed notice—Act, s 52

For section 52(2)(d) of the Act, the prescribed fee is \$83.20.

### 5 Documents relating to proof of engaged person's identity—Act, s 52

- (1) For section 52(3)(b) of the Act, a funded non-government service provider must sight 1 primary identification document, and 1 secondary identification document, for the engaged person.
- (2) At least 1 of the documents sighted under subsection (1) must show the engaged person's signature.

- (3) If the engaged person's name in a document sighted under subsection (1) differs from the engaged person's current name, the provider also must sight—
- (a) an official document evidencing the engaged person's change of name; or
  - (b) a document the chief executive considers provides sufficient evidence of the engaged person's change of name.

*Examples for subsection (3)(a) of an official document evidencing a change of name—*

- 1 marriage certificate
- 2 deed poll

**6 Fee for application for cancellation—Act, s 82**

For section 82(5)(c) of the Act, the prescribed fee is \$83.20.

**7 Fee for application for replacement—Act, s 92**

For section 92(2) of the Act, the prescribed fee is \$12.60.

**8 Fee for application for an eligibility declaration—Act, s 99**

For section 99(4)(c) of the Act, the prescribed fee is \$83.20.

**8A Information about restrictive practice approvals—Act, s 199(2)**

- (1) This section applies if a relevant service provider is given a restrictive practice approval to use a restrictive practice in relation to an adult with an intellectual or cognitive disability.
- (2) The relevant service provider must give the following information to the chief executive—
  - (a) the adult's—
    - (i) full name; and
    - (ii) unique client identifier; and

- (iii) date of birth; and
  - (iv) gender; and
  - (v) primary disability;
  - (b) the relevant service provider's—
    - (i) name; and
    - (ii) provider number; and
    - (iii) contact telephone number; and
    - (iv) email address;
  - (c) the type of disability services provided by the service provider;
  - (d) the person, identified by name or position title, authorised by the service provider to use the restrictive practice;
  - (e) the type of approval;
  - (f) the restrictive practice;
  - (g) who gave the approval;
  - (h) the date of the positive behaviour support plan for the adult that provides for the use of the restrictive practice;
  - (i) the date the approval was given;
  - (j) the date the approval expires.
- (3) If the restrictive practice approval is changed in a way that changes the information given under subsection (2), the relevant service provider must give the changed information to the chief executive.
- (4) The relevant service provider must give the information to the chief executive in the form approved by the chief executive.
- (5) The relevant service provider must give the information to the chief executive within 14 days after the approval or change to which the information relates is given or made.
- (6) In this section—

*provider number*, for a relevant service provider, means the unique number allocated to the relevant service provider under a service contract between the relevant service provider and the department.

**8B Information about use of restrictive practices—Act, s 199(2)**

- (1) This section applies if a relevant service provider uses a restrictive practice in relation to an adult with an intellectual or cognitive disability.
- (2) The relevant service provider must give the following information to the chief executive for each calendar month in which the restrictive practice is used—
  - (a) the adult’s full name;
  - (b) the adult’s unique client identifier;
  - (c) the restrictive practice used;
  - (d) the days on which, or the days between which, the restrictive practice was used;
  - (e) the times when the restrictive practice started and ended on each of the days;
  - (f) the frequency with which the restrictive practice was used;
  - (g) any episodic or isolated uses of the restrictive practice;
  - (h) the place where the restrictive practice was used;
  - (i) any injury to a person that happened when the restrictive practice was used;
  - (j) if a mechanical or physical restraint was used—the type of restraint;
  - (k) if the restrictive practice involved restricting access to an object—the object;
  - (l) if a medication was used as a chemical restraint—
    - (i) the generic name of the medication; and

- (ii) the proprietary name of the medication; and
  - (iii) the prescribed dose of the medication; and
  - (iv) the prescribed frequency of the dose of the medication; and
  - (v) the name of the doctor who prescribed the medication.
- (3) The relevant service provider must give the information to the chief executive using an electronic system approved by the chief executive.
- (4) The relevant service provider must give the information to the chief executive—
- (a) on the second Friday of the calendar month immediately after the calendar month in which the restrictive practice is used; and
  - (b) at other times if the chief executive, by written notice, requires the relevant service provider to do so.
- (5) A notice under subsection (4)(b) must state—
- (a) the period to which the information must relate; and
  - (b) the type of information, mentioned in subsection (2), that the relevant service provider is required to give; and
  - (c) when the relevant service provider must give the information to the chief executive.

## **9 Records—Act, s 215**

- (1) The records required to be made and kept by a funded non-government service provider under section 215 of the Act are the following—
- (a) the address of each of the provider's service outlets;
  - (b) the name, address and telephone number for each of the provider's consumers;

- (c) the name, address and telephone number for the person nominated as the emergency contact for each of the provider's consumers;
  - (d) the following relating to the screening of persons engaged or proposed to be engaged by the provider—
    - (i) copies of applications or other documents given by the provider to the chief executive;
    - (ii) documents received by the provider from the chief executive;
  - (e) documents relating to written complaints made to the provider about the delivery of disability services by the provider;
  - (g) copies of documents given by the provider to the chief executive relating to incidents that have happened in the provision of disability services by the provider;
  - (h) if a compliance notice has been given to the provider, a copy of the compliance notice;
  - (k) the financial records required to be kept by the provider under the funding agreement entered into by the provider.
- (2) The records mentioned in subsection (1) must be kept for at least 7 years.
- (3) In this section—
- compliance notice*** see the *Community Services Act 2007*, section 19(1).

## Part 2 Transitional provisions

### 10 Screening of persons engaged by funded non-government service providers—Act, s 236

- (1) For section 236 of the Act, the first column of schedule 3 names a funded non-government service provider and the second column assigns a category to that service provider.
- (2) The following periods apply to the categories assigned—
  - (a) category 1—4 months after the commencement;
  - (b) category 2—5 months after the commencement;
  - (c) category 3—6 months after the commencement.
- (3) In this section—

*category 1* means accommodation support services or respite services.

*category 2* means community support services or community access.

*category 3* means—

- (a) advocacy or information services or services that provide alternative forms of communication; or
- (b) research, training or development services.

*commencement* means the commencement of the Act, part 16.

### 11 Transitional provision for Disability Services and Other Legislation Amendment Regulation (No. 1) 2014

- (1) For section 9(1)(h), a reference to a compliance notice includes a compliance notice given under former section 161 of the Act.
- (2) In this section—

*former section 161*, of the Act, means section 161 of the Act as in force from time to time before its repeal by the

## **Schedule 1AA Prescribed disability services—Act, ss 12, 14 and 16A**

### section 3A

- 1 assistance with daily life tasks in a group or shared living arrangement
- 2 assistance with daily personal activities
- 3 development of daily living and life skills
- 4 therapeutic support
- 5 early intervention supports for early childhood
- 6 behaviour support
- 7 assistance in coordinating or managing life stages, transitions and supports
- 8 management of funding for supports under a participant's plan
- 9 assistive technology specialist assessment, set-up and training
- 10 participation in community, social and civic activities
- 11 training for independence in travel and transport
- 12 interpreting and translation

## **Schedule 1      Primary identification documents**

### section 5

- birth certificate
- current Australian driver licence containing a photograph of the engaged person
- international travel document
- citizenship certificate
- visa or entry permit under the *Migration Act 1958* (Cwlth)
- current consular identity document containing a photograph of the engaged person
- a document the chief executive considers provides sufficient identification of the engaged person

## Schedule 2      Secondary identification documents

## section 5

- recent account or notice issued by a public utility

*Examples—*

- 1 council rates notice
- 2 electricity account statement
- 3 gas account statement
- 4 land valuation notice
- 5 telephone account statement

- recent document evidencing electoral enrolment
- identification card issued by the Commonwealth or a State as evidence of the engaged person's entitlement to a financial benefit

*Examples—*

- 1 Commonwealth seniors health card
- 2 health care card
- 3 medicare card
- 4 pensioner concession card
- 5 repatriation health card

- current account card, or current credit card, issued by a financial institution

*Note—*

See the *Acts Interpretation Act 1954*, schedule 1, definition *financial institution*.

- account statement issued by a financial institution that shows the statement's date of issue to be less than 1 year before the statement is sighted
- passbook issued by a financial institution that shows the passbook's last entry to be less than 1 year before the passbook is sighted

- a document the chief executive considers provides sufficient identification of the engaged person

## Schedule 4 Dictionary

### section 3

***Australian driver licence*** see the *Transport Operations (Road Use Management) Act 1995*, schedule 4.

***Australian electoral roll*** means an electoral roll maintained under a law of the Commonwealth or a State.

***birth certificate***, for an engaged person, means a certified copy of a birth certificate of the engaged person containing the name of at least 1 of the engaged person's parents.

***citizenship certificate***, for an engaged person, means a certificate, declaration or other instrument of the engaged person's nationality issued under the *Australian Citizenship Act 1948* (Cwlth).

*Note—*

*Australian Citizenship Act 1948* (Cwlth)—see the *Acts Interpretation Act 1954*, section 14H and the *Australian Citizenship Act 2007* (Cwlth).

***consular identity document***, for an engaged person, means a document showing the engaged person is a member of a consular post.

***document evidencing electoral enrolment***, for an engaged person, means—

- (a) a document that is part of an Australian electoral roll and sets out the engaged person's name; or
- (b) a document issued by an entity responsible for maintaining an Australian electoral roll that shows the engaged person's name is set out in an Australian electoral roll.

***international travel document*** means—

- (a) a current passport; or

- (b) an expired passport that expired less than 2 years before the expired passport is sighted; or
- (c) another current identity document, having the characteristics of a passport, issued by a government, the United Nations or an agency of the United Nations for the purposes of international travel; or
- (d) another expired identity document, having the characteristics of a passport, issued by a government, the United Nations or an agency of the United Nations for the purposes of international travel that expired less than 2 years before the expired identity document is sighted.

***member of a consular post*** has the same meaning as in the *Consular Privileges and Immunities Act 1972* (Cwlth).
