This regulation may be cited as the *Forestry (State Forests) and Other Legislation Amendment Regulation 2022*.

For the *Nature Conservation Act 1992*, section 70E(3), the purpose of the revocation of the dedication of a forest reserve under section 6 is to allow the forest reserve to become a protected area.
