Part 1 Preliminary

1 Short title

This regulation may be cited as the *Nature Conservation (Fee Waivers) and Other Legislation Amendment Regulation 2024.*

2 Regulation amended

This part amends the Forestry Regulation 2015.

3 Insertion of new s 39A

After section 39—

insert—

39A Commercial activity permit—daily activity fee waived for tropical cyclone Jasper

- (1) This section applies in relation to a daily activity fee payable under the Act for conducting a commercial activity under a commercial activity permit—
 - (a) in a State forest, timber reserve or forest reserve within a cyclone-affected area; and
 - (b) on a day during the period starting on 1 January 2024 and ending on 31 March 2024.
- (2) Payment of the fee is waived for the holder of the commercial activity permit.
- (3) This section expires on 30 June 2024.
- (4) In this section—

cyclone-affected area means a local government

- (a) called 'Tropical Cyclone Jasper, associated rainfall and flooding, 13–28 December 2023'; and
- (b) published on the authority's website.

Queensland Reconstruction Authority means the Queensland Reconstruction Authority established under the *Queensland Reconstruction Authority* Act 2011, section 7.

 - (b) on a day during the period starting on 1 January 2024 and ending on 31 March 2024.
- (2) Payment of the fee is waived for the holder of the commercial activity permit.
- (3) This section expires on 30 June 2024.
- (4) In this section—

additional daily fee, in relation to a commercial activity permit, means the fee mentioned in schedule 2, item 13(d)(i).
