Part 1 Preliminary

1 Short title

This regulation may be cited as the *Petroleum and Gas* (*Production and Safety*) Legislation Amendment Regulation 2024.

2 Commencement

This regulation commences on 4 April 2024.

Part 2 Amendment of Petroleum and Gas (General Provisions) Regulation 2017

3 Regulation amended

This part amends the *Petroleum and Gas (General Provisions) Regulation 2017.*

4 Replacement of s 6 (Substances that are fuel gas)

Section 6—

omit, insert—

6 Substances that are fuel gas

- (1) For the 2004 Act, section 11(2)(d), the following substances are prescribed—
 - (a) biogas;
 - (b) biomethane;
 - (c) synthetic methane;
 - (d) a substance that is a mixture of LPG and air, known as 'synthetic natural gas'.

(2) In this section—

synthetic methane means a substance—

- (a) that is in a gaseous state at standard temperature and pressure; and
- (b) the principal constituent of which is methane; and
- (c) that is produced by the methanation of carbon dioxide; and
- (d) that is suitable for consumption.

6A Substances that are regulated hydrogen

For the 2004 Act, section 11A(c), the following substances are prescribed—

- (a) ammonia;
- (b) dimethyl-ether;
- (c) methanol;
- (d) methyl-cyclohexane (MCH);
- (e) toluene.

5 Amendment of s 59 (Other requirements for accuracy of meter—100TJ to 1PJ)
