1 Short title

This declaration may be cited as the *Fisheries Amendment Declaration 2024*.

2 Declaration amended

This declaration amends the Fisheries Declaration 2019.

3 Amendment of s 23 (Taking or possessing regulated coral reef fin fish in regulated periods—coral reef fin fish waters)

118 Recreational fisher taking spanish mackerel in Gulf of Carpentaria waters

- (1) This section applies to a recreational fisher who is, or has been, on a boat and taking part in a licensed charter fishing trip that is conducted—
 - (a) for a continuous period of at least 48 hours; and
 - (b) entirely in the Gulf of Carpentaria waters.
- (2) The recreational fisher may—

(a)	during the licensed charter fishing trip, take				
	twice the regulated maximum number of				
	spanish mackerel; and				

(b) possess the fish taken under paragraph (a).
