community pharmacy means—

- (a) a place at which a person owns and carries on a pharmacy business under the *Pharmacy Business Ownership Act 2001*; or
- (b) if the *Pharmacy Business Ownership Act* 2024, section 19 has commenced—
 - (i) the licensed premises for a licensed pharmacy business under that Act; or

(ii) a place at which a person may continue to own and carry on a pharmacy business, without holding a pharmacy business licence, under that Act.

therapeutic nicotine means nicotine in a therapeutic vaping good.

therapeutic vaping good see the *Therapeutic Goods Regulations 1990* (Cwlth), section 2.
