# Appropriation (Supplementary 2024–2025) Act 2026

**An Act authorising the Treasurer to pay amounts from the consolidated fund for particular departments for the financial year starting 1 July 2024**

## **1 Short title**

This Act may be cited as the *Appropriation (Supplementary 2024–2025) Act 2026*.

*Note—*

Under the *Financial Accountability Act 2009*, section 5, words used in this Act that are defined under the *Financial Accountability Act 2009* have the same meaning the words have in that Act, subject to a contrary intention in this Act.

## **2 Supplementary appropriation for 2024–2025 based on unforeseen expenditure included in the consolidated fund financial report**

- (1) The Treasurer is authorised to pay \$5,740,982,000 from the consolidated fund for departments as stated in schedule 1 for the financial year starting 1 July 2024.
- (2) For each department, the total amount mentioned for the department in schedule 1 is appropriated for the financial year for the department for application to its departmental services, equity adjustment and administered items as stated in schedule 1.
