# **GRAMMAR SCHOOLS REGULATION 1992**

[as amended by all amendments that commenced on or before 5 May 1998]

## **Short title**

1. This regulation may be cited as the *Grammar Schools Regulation 1992*.

## **Commencement**

2. This regulation commences on 1 July 1992.

## **Donations and subscriptions**

3. For the purposes of section 7(4)(d) of the Act, the prescribed amount is \$50.

## ***Repeal of Grammar Schools Inscribed Stock Regulation 1962***

4.(1) *To remove doubt, it is declared that the Grammar Schools Inscribed Stock Regulation 1962 is repealed.*

(2) *This section expires the day it commences.*<sup>1</sup>
