## **REGULATORY REFORM REGULATION 1993**

[as amended by all amendments that commenced on or before 13 July 1994<sup>2</sup>]

### **Short title**

1. This regulation may be cited as the *Regulatory Reform Regulation 1993*<sup>3-5</sup>.

### **Exemption of subordinate legislation**

2. The subordinate legislation set out in Schedule 1 is exempted from the application of the Act.

### **Continuation of subordinate legislation**

3.(1) The expiry of the subordinate legislation set out in Schedule 2 is deferred until 31 December 1994.
