1 Short title

This regulation may be cited as the *Partnership (Limited Liability) Regulation 1993*.

3 Approval of forms

The chief executive may approve a form for a purpose—

- (a) for which a prescribed form is required or authorised to be used under the Act or this regulation; or
- (b) in connection with the administration of the Act or this regulation.

4 Fees

The fees payable under the Act are set out in the schedule.
