Short title

1. This regulation may be cited as the *Statutory Bodies Financial Arrangements (Investment with Financial Institutions) Regulation 1993*³.

Meaning of “foreign society”

2. In this regulation—

“foreign society” has the meaning given by the Financial Institutions (Queensland) Code.

Application of s.48(1)(d) of the Act

3. Section 48(1)(d) of the Act is declared to apply to a local authority, without limit of time, in respect of a deposit with a building society, credit union or foreign society.
