Short title

1. This regulation may be cited as the *Willows Sports Complex Regulation 1993*.

Tenders not required

2. For the purposes of section 4(2) of the Act, section 19(4) of the *Local Government Act 1936* does not apply to agreements made by the Willows Sports Complex Joint Board for works, and goods and materials incidental to the works, specified in the Schedule.
