1 Short title

This regulation may be cited as the *District Court Regulation 1993*.

2 Places where court is to be held and declaration of districts

- (1) The District Court is to be held at the places mentioned in the schedule, column 1.
- (2) The district for the District Court at a place mentioned in the schedule, column 1, consists of the district or districts for Magistrates Courts mentioned in the schedule, column 2 set out opposite the place.
