## **PLANT PROTECTION (PAPAW RINGSPOT) QUARANTINE NOTICE 1994**

[reprinted as in force on 10 March 1994<sup>2</sup>]

### **Short title**

1. This notice may be cited as the *Plant Protection (Papaw Ringspot) Quarantine Notice 1994*<sup>3-4</sup>.

### **Definitions**

2. In this notice—

“**papaw ringspot**” means the pest papaya ringspot virus;

“**pest quarantine area**” means the pest quarantine area for papaw ringspot;<sup>1</sup>

“**plant**” includes a part of a plant (other than the fruit or seed);

“**prohibited plant**” means—

- (a) a plant of the genus *Carica*; or
- (b) a plant of the family Cucurbitaceae.

### **Objects of quarantine (s 11(2) of the Act)**

3. The objects of the quarantine are—

- (a) to prevent papaw ringspot being brought into the pest quarantine area; and
- (b) to prevent papaw ringspot being spread in the pest quarantine area.

**Nature of quarantine (s 11(2) of the Act)**

**4.(1)** A person must not—

- (a) bring a prohibited plant into the pest quarantine area; or
- (b) have a prohibited plant in the pest quarantine area; or
- (c) plant a prohibited plant in the pest quarantine area.

**(2)** Subsection (1) does not apply to a prohibited plant brought into the pest quarantine area with an inspector's written approval.

**(3)** An inspector may give an approval under subsection (2) only if the inspector is satisfied the plant is free of papaw ringspot.
