SUPERANNUATION (GOVERNMENT AND OTHER EMPLOYEES) REGULATION 1994

[as amended by all amendments that commenced on or before 27 March 1994]

Short title

1. This regulation may be cited as the *Superannuation (Government and Other Employees) Regulation 1994*.

Persons approved to be a member of scheme

2.(1) For the purposes of section 3(2)(d) (Definition of “employee”) of the Articles, a person specified in schedule 1 is approved to be a member of the scheme.

(2) However, schedule 1, items 2 and 3 do not apply to a person who is a member of a superannuation scheme the Minister decides is a scheme to which this subsection applies.

Persons excluded from membership of scheme

3. For the purposes of section 3(3)(e) (Definition of “employee”) of the Articles, a person specified in schedule 2 is excluded from membership of the scheme.
