**MEDICAL ACT AND OTHER ACTS
(ADMINISTRATION) REGULATION 1994**

[as amended by all amendments that commenced on or before 13 May 1997]

Short title

1. This regulation may be cited as the *Medical Act and Other Acts (Administration) Regulation 1994*.

Contributions to be made by certain boards to consolidated fund—Act s 4

2. Each board mentioned in the schedule must pay to the consolidated fund—

- (a) the specified percentage of the amount received from the consolidated fund for the salaries of the registrar and other officers of the board; and
- (b) the specified percentage of the amount received from the consolidated fund for the administrative costs of the board.
