# Superannuation (State Public Sector) Regulation 1996

[as amended by all amendments that commenced on or before 23 September 2005]

## 1 Short title

This regulation may be cited as the *Superannuation (State Public Sector) Regulation 1996*.

## 2 Commencement

This regulation commences on 1 February 1996.

## 3 Declared units of the State public sector

For section 2(1) of the Act, definition *unit of the State public sector*, each of the entities mentioned in the schedule is a unit of the State public sector.

## 3A Declared eligible schemes

For section 2A of the Act, the following superannuation schemes are eligible schemes for the Act—

- Q•Invest Retirement Fund
- Parliamentary Contributory Superannuation Fund established under the *Parliamentary Contributory Superannuation Act 1970*
- Queensland Ambulance Service Superannuation Scheme established under the *Ambulance Service Act 1991*.

## **5 Protected expressions—Act, s 21**

The following expressions are declared to be expressions to which section 21<sup>1</sup> of the Act applies—

- ‘QSuper’
- ‘RailSuper’.

## **6 Retrospective effect of certain declarations**
