1 Short title

This regulation may be cited as the *Trustee Companies Regulation 1996*.

2 Investment of part of paid-up capital

The sum that is directed under section 56(1A) of the Act in relation to trustee companies generally is \$100000.

3 Repeals

All subordinate legislation made under the Act, and in force immediately before the commencement, is repealed.
