This regulation may be cited as the *Water Resources (Maximum Fees for Board Members) Regulation 1996*.

2 Maximum fees

For section 215(2) of the Act,¹ the maximum amount of a fee for a purpose stated in table A, column 1 is the amount stated in table A, column 2.
