## 1 Short title

This regulation may be cited as the *Drugs Standard Adopting Regulation 1996*.

## 2 British pharmacopoeia—Act, s 5

- (1) The 1993 edition of the British pharmacopoeia has effect for the Act.
- (2) The additions to, or amendments of, the 1993 edition, stated in the schedule also have effect for the Act.

## 3 Repeal

All statutory instruments made under the Act, other than this regulation, are repealed.
