1 Short title

This regulation may be cited as the *Civil Aviation (Carriers' Liability) Regulation 1996*.

2 Commencement

This regulation commences on 1 December 1996.

3 Carrier's liability for death or injury to a passenger

A carrier's liability for the death of, or injury to, a passenger in an accident is limited to \$500000.
