## **1 Short title**

This standard may be cited as the *Meat Industry (Construction of Premises Processing Meat for Human Consumption) Standard 1996*.

## **2 Standard**

The standard for the construction of premises processing meat for human consumption is the Australian Standard for Construction of Premises Processing Meat for Human Consumption endorsed by the Agriculture and Resource Management Council of Australia and New Zealand.<sup>1</sup>
