**1 Short title**

This order in council may be cited as the *Stamp (Mortgage, Bond, Debenture and Covenant) Order 1997*.

**2 Approved instruments exempt**

The instruments mentioned in the schedule are approved as instruments to which clause 5 of the exemptions under the heading “MORTGAGE, BOND, DEBENTURE, AND COVENANT” in schedule 1 of the Act applies.
