1 Short title

This regulation may be cited as the *Petroleum Products Subsidy Regulation 1998*.

2 Definitions

In this regulation—

claim for a payment means a claim by a registered distributor of eligible petroleum products for a payment under the Act.

3 Claims for payments—Act, s 6

- (1) An authorised officer may approve the form of a claim for a payment.
- (2) A claim for a payment must be in the form approved under subsection (1).

4 Repeal

The *Petroleum Products Subsidy Regulation 1978* is repealed.
