Short title

1. This notice may be cited as the *Primary Producers' Organisation and Marketing (Commercial Fishers General Levy) Notice 1998*.

Amount of levy

2. Under section 30F(10)(b)¹ of the Act, the general levy made on members of commercial fishermen's local branches is \$485.

Payment of levy

3.(1) A member must pay the levy if a licence is issued to the member or if the member's licence is renewed.

(2) The levy must be paid to the Secretary, Queensland Commercial Fishermen's Organisation² or the Queensland Fisheries Management Authority.³

(3) In subsection (1)—

"licence" means—

(a) a commercial fisher licence or a primary or tender commercial

- fishing boat licence issued under the *Fisheries Act 1994*; or
- (b) a master fisherman's licence granted under the *Torres Strait Fisheries Act 1984* (Cwlth).

Repeal

4.(1) The Primary Producers' Organisation and Marketing (Commercial Fishers General Levy) Notice 1997 is repealed.

(2) This section expires the day after it commences.⁴
