1 Short title

This notice may be cited as the *Cooperatives Exemption Notice 1999*.

2 Exemption for Mooraridgi Community Advancement Co-operative Society Limited

Mooraridgi Community Advancement Co-operative Society Limited (the *cooperative*) is exempt from compliance with section 268(1)(a) and (d) of the Act for the disposal by the cooperative's administrator of up to 15 pieces of land.
