1 Short title

This regulation may be cited as the *Local Government (Malls) Regulation 2000*.

2 Penalty for prescribed infringement

For the *Local Government (Chinatown and The Valley Malls) Act 1984*, section 31 and the *Local Government (Queen Street Mall) Act 1981*, section 25, the penalty is 1 penalty unit.

3 Repeal

The *Local Government (Chinatown and The Valley Malls) Regulation 1990* is repealed.
