Spelling

Dates shown on reprints

Reprints dated at last amendment All reprints produced on or after 1 July 2002, authorised (that is, hard copy) and unauthorised (that is, electronic), are dated as at the last date of amendment. Previously reprints were dated as at the date of publication. If an authorised reprint is dated earlier than an unauthorised version published before 1 July 2002, it means the legislation was not further amended and the reprint date is the commencement of the last amendment.

If the date of an authorised reprint is the same as the date shown for an unauthorised version previously published, it merely means that the unauthorised version was published before the authorised version. Also, any revised edition of the previously published unauthorised version will have the same date as that version.

Replacement reprint date If the date of an authorised reprint is the same as the date shown on another authorised reprint it means that one is the replacement of the other.

1 Short title

This regulation may be cited as the *Statistical Returns Regulation 2001*.

2 Matters about which government statistician may collect and publish statistics—Act, s 4(1)(s)

For section 4(1)(s) of the Act, the government statistician may collect and publish statistics about the production or supply of energy, including, for example, the production or supply of electricity or gas.
