# Governors (Salary and Pensions) Regulation 2003

## 1 Short title

This regulation may be cited as the *Governors (Salary and Pensions) Regulation 2003*.

## 2 Commencement

This regulation commences on 29 July 2003.

## 3 Salary rate—Act, s 3

For section 3 of the Act, the rate is an amount for a financial year that is equal to 90% of the amount that a Supreme Court judge, other than the Chief Justice or the President of the Court of Appeal, is entitled to be paid for the financial year as salary under the *Judicial Remuneration Act 2007*.
