1 Short title

This regulation may be cited as the *District Court Regulation 2005*.

2 Declaration of places at which District Court to be held and District Court districts—Act, ss 6 and 7

- (1) For sections 6(3)(a) of the Act, the places at which the District Court is to be held are mentioned in the schedule, column 1.
- (2) For section 7(1) of the Act, the district for the District Court at a place mentioned in the schedule, column 1, consists of the Magistrates Courts district mentioned in the schedule, column 2 set out opposite the place.

3 Repeal

The District Court Regulation 1993 SL No. 498 is repealed.
