## **Plant Protection (Mango Leaf Gall Midge) Quarantine Notice 2006**

### **1 Short title**

This notice may be cited as the *Plant Protection (Mango Leaf Gall Midge) Quarantine Notice 2006*.

*Note—*

Under section 11(9) of the Act, this notice remains in force until whichever of the following first happens—

- (a) the commencement of a regulation under section 11(1) of the Act in relation to the same matter; or
- (b) the end of 3 months.

### **2 Definitions**

In this notice—

***host plant*** means a mango plant or a part of a mango plant, including, for example, the fruit of a mango plant.

***mango leaf gall midge*** means the pest, mango leaf gall midge *Procontarinia* spp., declared under the *Plant Protection (Mango Leaf Gall Midge) Notice 2006*.

***pest quarantine area*** means a pest quarantine area declared under section 3.

### **3 Declaration of pest quarantine areas**

Each of the following areas is declared to be a pest quarantine area for mango leaf gall midge—

- (a) Darnley Island;
- (b) Murray Island;
- (c) Stephen Island.

**4 Object of quarantine**

The object of the quarantine for a pest quarantine area is to prevent mango leaf gall midge being brought out of the pest quarantine area.

**5 Restrictions on movement out of pest quarantine area**

A person must not, without an inspector's approval, move a mango leaf gall midge, or a host plant, out of a pest quarantine area.
