Fair Trading (Bindeeze) Order 2007

1 Short title

This order may be cited as the *Fair Trading (Bindeeze) Order 2007*.

2 Supply of Bindeeze prohibited

(1) The supply of Bindeeze is prohibited under section 85 of the Act.

(2) In this section—

Bindeeze means Bindeeze brand beads that join with a spray of water.

Editor's note—

Section 85 of the Act deals with the Minister making orders prohibiting or restricting the supply of dangerous or undesirable goods or services. Under section 85(5) of the Act, this order expires 18 months after the order commences, and may not be renewed.
