# Trans-Tasman Mutual Recognition (Endorsement) Notice 2025

## 1 Short title

This notice may be cited as the *Trans-Tasman Mutual Recognition (Endorsement) Notice 2025*.

## 2 Endorsement of proposed Commonwealth regulations—Act, s 7

The proposed Commonwealth regulations titled ‘Trans-Tasman Mutual Recognition (Continuation of Temporary Exemption of Public Health (Tobacco and Other Products) Act 2023) Regulations 2025’, the terms of which are set out in schedule 1, are endorsed.

## Part 1      **Preliminary**

### 1      **Name**

This instrument is the *Trans-Tasman Mutual Recognition (Continuation of Temporary Exemption of Public Health (Tobacco and Other Products) Act 2023) Regulations 2025*.

### 2      **Commencement**

### **5 Repeal of this instrument**

This instrument is repealed at the end of 31 March 2026.

## **Part 2 Continuation of temporary exemption**

### **6 Continuation of temporary exemption of *Public Health (Tobacco and Other Products) Act 2023***

For the purposes of subsection 47(3) of the Act, the *Public Health (Tobacco and Other Products) Act 2023* is declared to be exempt from the operation of the *Trans-Tasman Mutual Recognition Act 1997*.

Note: This section is to revive the effect of an exemption under section 46 of the Act. For that exemption, see section 12 of the *Public Health (Tobacco and Other Products) Regulations 2024*.
